We are happy to introduce this Annual Report of the Mid and East Antrim Policing and Community Safety Partnership (MEA PCSP) which showcases achievements over the 2024–2025 period. MEA PCSP considers the community safety issues which local people identify as being of great importance and works alongside partners in seeking to address those issues. The Policing Committee of the Partnership also brings the views of local people into consideration when working alongside the District Commander in setting local targets for the police service to achieve.

We are delighted with the projects and initiatives that our PCSP has delivered in 2024-25 to help make sure that the aims and objectives identified within the PCSP Strategy were achieved. This year has seen the successful delivery of our Action Plan, which continues to drive forward our mission of building safer, more resilient communities across the Borough.

Important work also continues with partners to reduce vulnerability in Mid and East Antrim, with Support Hub meetings on a regular basis supporting the most vulnerable people in our Borough. The PCSP Drugs and Alcohol Steering Group also continues its work to bring a local focus to the vulnerability that arises from Drugs and Alcohol issues, led by our strategic partner ASCERT, alongside a range of other key stakeholders from the statutory and community sectors who bring specialism and expertise to this important area of work. Domestic and sexual violence continues to be an issue in Mid and East Antrim, and our PCSP continues to resource the Northern Domestic & Sexual Violence and Abuse Partnership to coordinate efforts on these issues locally, alongside other key partners.

This Programme's success is testament to the continued support of our partnership members, delivery partners, and the communities we serve. Their commitment and innovation have enabled meaningful engagement, responsive action, and real change at local level. We wish to acknowledge the work, guidance and support of our fellow PCSP members, and the staff of Mid and East Antrim Borough Council who have assisted the Partnership and everyone who has been involved in making Mid and East Antrim PCSP successful throughout 2024-25.

Furthermore, we extend our thanks and gratitude to our funders from the Joint Committee, the Northern Ireland Policing Board and the Department of Justice, whose ongoing support has been instrumental in enabling us to implement our objectives effectively and strategically.

Executive Summary

Mid and East Antrim Policing and Community Safety Partnership (PCSP) is one of 11 PCSPs in Northern Ireland working to help make communities safer and to ensure that the voices of local people are heard on policing and community safety issues.

The aim of Mid and East Antrim PCSP is to engage and empower communities and to develop solutions in partnership to tackle crime, fear of crime and anti-social behaviour.

The PCSP has demonstrated good progress in 2024–2025, delivering impactful initiatives that have enhanced community safety, tackled Anti-social Behaviour, and helped to build community confidence in the Police Service across the Borough.

Community Safety Initiatives

The PCSP's commitment to community safety is evident through its comprehensive approach, addressing key areas such as anti-social behaviour, substance issues, and domestic and sexual violence. By establishing three focused working groups, the PCSP has coordinated efforts to tackle these issues, fostering safer environments for residents. Throughout the work of the Partnership there is a strong focus on addressing vulnerability. The PCSP also works with those who have been direct victims of crime through delivery of the Four Tier Security initiative.

Tackling Anti-social Behaviour

The Partnership has maintained a strong interagency approach to addressing Anti-social Behaviour (ASB). This is operationalised on a regular basis through the work of the MEA Anti-social Behaviour Working Group. A guiding principle of this working group is to provide additional inter-agency support to the PSNI Neighbourhood Police Teams (NPT) in Ballymena and East Antrim as they work to address ASB. Without the ongoing work of this forum the levels of ASB in Mid and East Antrim would be on a very different trajectory.

Community Engagement and Building Confidence

The PCSP has actively engaged with a wide range of community groups, providing platforms for dialogue and collaboration. Through programmes like the Agile Local Response Initiative, Council's DEA Officers have worked alongside the PSNI Neighbourhood Policing Teams in targeted localities to address community safety issues and to build confidence. This empowers local residents to implement their own community safety projects, fostering a sense of ownership and collective responsibility.

Conclusion

In summary, the efforts of Mid and East Antrim PCSP in 2024–2025 has significantly contributed to reducing anti-social behaviour and improving community safety. This has been achieved by addressing societal issues, supporting victims, and empowering local groups, the PCSP has made important advances in making Mid and East Antrim a safer Borough.

Background of MEA PCSP

Our Borough

The Borough of Mid and East Antrim covers an area of just over 400 square miles extending from the River Bann in the west, to the beautiful Antrim coast in the east, and includes part of the Antrim Coast and Glens Area of Outstanding Natural Beauty. There are 3 main towns, Ballymena, Carrickfergus and Larne, and a host of welcoming villages and rural communities, which are home to a population of just under 140,000 people.

Our Council

Mid and East Antrim Borough Council is committed to developing and maintaining strong partnerships with organisations – including community groups and public, private, and third sector organisations – from across Northern Ireland to deliver on shared outcomes and goals, which can only be achieved when we work together.

Over the years, Council has collaborated with partners to deliver a range of awareness raising campaigns, community events, training sessions and transformational projects for the lifelong benefit of citizens. In the 2024-2028 Corporate Plan, Council pledges to continue working with partners on the issues impacting our communities such as, poverty, unemployment, mental health awareness, suicide prevention and safety on our roads.

Our Community Plan - Putting People First

Mid and East Antrim's **Putting People First** is the Community Plan for MEA, covering the 15-year period from 2017-2032. The vision for MEA is that "*Mid and East Antrim will be a strong, vibrant, safe and inclusive community, where people work together to improve the quality of life for all.*" The community planning process has identified three strategic priorities for the theme: Community Safety and Cohesion, each of which has its own outcome.

These are:

- **Vulnerable People:** "Our people feel safe in their community and have a sense of belonging to the area"
- **Those most at Risk of Creating Crime:** "Our borough has structured arrangements to support and deter those most at risk of becoming involved in crime"
- **Vulnerable Places:** "Our borough has vibrant, shared and cohesive communities"





The "Roadsafe Roadshow" had been developed to recognise and address the issue of young people aged under 25 who are most at risk of being killed or suffering serious injury on our roads. Through this event MEA PCSP promoted a powerful message of community safety targeted at young drivers and created an opportunity for our PCSP Chair and Vice Chair to engage with this age group of the MEA community to promote the work of PCSP.

Description of project/initiative/event	<p>Supported as part of the PCSP Agile Local Response Initiative. This project had important involvement from the DEA Officer for Bannside and Ballymena Neighbourhood Police Team.</p> <p>This Youth intervention project, in partnership with Cullybackey Village Community Group, engaged at-risk young people to reduce antisocial behaviour and promote community safety in the village. Through mentorship, education, and positive activities, this project worked to empower young people to make better choices, build life skills, and strengthen community ties—creating a safer, more inclusive environment for residents in the local community.</p>
Impact of the project/initiative/event	<p>The Agile Youth project had a really positive impact in the village, particularly in addressing anti-social behaviour. The funding came at a crucial time and allowed us to deliver targeted activities that were both engaging and meaningful for the young people involved.</p> <p>One young person commented, <i>"It was the first time I felt like something was actually for us – we got to do things that mattered and felt listened to."</i></p> <p>A youth volunteer also noted, <i>"You could really see the shift in attitudes. The Role of Neighbourhood Watch

Council District Electoral Officers (DEA) Officers work alongside the PSNI Neighbourhood Police Teams to support Neighbourhood Watch Schemes across the Borough. They do this through communication activities, such as the text alert scheme and circulation of a Neighbourhood Watch Newsletter. In 2024-2025 there were two editions of Neighbourhood Watch newsletters produced and circulated to Neighbourhood Watch Schemes in MEA and online via PCSP and Council social media channels. It is recognised that Neighbourhood Watch is a useful tool for engaging communities in support of the PSNI in Crime Prevention.

The Important Work of Mid and East Antrim Policing Committee

Throughout the year, the Partnership holds Private Policing Committee meetings at which the PSNI District Commander presents a performance report and takes questions from all PCSP members. The Policing Committee also meets in public at regular intervals. These meetings are publicly promoted and are easily accessible online. The facilitation of these meetings provides members of the public with an important opportunity to monitor PSNI performance and for the PSNI to engage with local communities.

The aim of Strategic Priority 3 is to support confidence in policing, including through collaborative problem solving in Mid and East Antrim with communities, by:

- Ensuring local accountability through the Policing Committee's role in monitoring police performance;
- Identifying priorities from the PCSP Plan for consideration in the development of the local Policing Plan which are consistent with the Northern Ireland Policing Plan.
- Providing views to the District Commander through the Policing Committee and supporting the PSNI to engage with the community to identify and address local problems.
- Delivering initiatives that link to identified local problems that impact confidence in policing.
- Carrying out meaningful local events aimed at increasing PSNI engagement with local communities to build and strengthen public confidence in policing.
- Delivering PCSP initiatives in the hardest to reach communities.
- Providing a platform for the PCSP and PSNI to engage with young people, including on the themes of upholding the rule of law, and of ways of increasing confidence in policing; and
- Building community confidence in the rule of law by helping mitigate the harm caused to people and communities by paramilitarism, criminality and organised crime consistent with wider Programme for Government objectives and through use of co-design principles, where appropriate.

Embedding a Culture of Lawfulness

Promoting a culture of lawfulness is a thread which runs throughout Mid and East Antrim PCSPs work. This can take the form of diverting at risk youth through our engagement opportunities or the community safety wardens patrolling both rural and urban communities, encouraging people to stand up to organised crime by increasing crime reports to the PSNI and promoting Crimestoppers.

The PCSP also collaborates with other partners on the removal of paramilitary and offensive graffiti. The DEA Officer team have also worked with individuals and groups involved in Communities in Transition (CIT). The PCSP Anti-social Behaviour subgroup and the DEA Team also led on a successful bid to the Ending Paramilitary Activity and Organised Crime (EPOC) funding stream. This resulted in a specialised "boot camp" programme targeting high risk young males in East Antrim over the summer months.

These activities and various forms of engagement have created opportunities and networks to promote community safety and build confidence at grassroots level. This area of work remains sensitive and ongoing.
